Entry Requirements (updated as at May 2018)

- Minimum must possess SPM with not less than 5 passes of which three (3) must be credit
- One of the credit must be in either Mathematic or Science or Commerce or Accounting.
- Minimum age at 21 years old

Course Terms

 A candidate may take all or at least two of six subjects in the respective part of one sitting and be given credits for the subjects passed which shall lapse in the end of the third year.

You need to pass all six subjects (Part 1 and Part II) within 3 years timeframe from the first subject(s) that passed in the examination sitting.

Example: You has first passed two subjects for Part I (or Part II papers) in August 2018 examination. Your passed credit will be retained for 3 years, that you are require to pass the remaining 4 papers by August 2021. Otherwise, your first passed subject(s) will needs to be re-sitting the examination again.

- A pass in all the above six subjects in Part 1 will makes the candidate eligible for Part II.
- Candidate must take Part II examination not later than 5 years after passing all the subject in Part 1 examination.

Once you passed all papers in Part 1, are required to proceed the Part II examination (at least 2 subjects) within the next 5 years Period. Otherwise, your Part I passed credit will be lapsed.

Example: You has passed all subjects in Part 1 in year 2018. You are required to take Part II examination by year 2023. Otherwise, in year 2024, you need to resit all Part I subjects again.

Exam papers

- Each subject consists of seven (7) or eight (8) questions and candidates will be required to answer 4 questions from the former and 5 questions from the later.
- The format of all the questions will be of a subjective nature and the same comprises of theoretical and problematic questions.
- The candidate may answer the question in Bahasa Malaysia or English
- Passing marks for each subject shall be at 50%
- Candidates will be supplies with Board Examination Pad for answer scripts

Results

- Candidate will be notified once results decided by the Board (in average of 3 months after exam)
- Any candidate dissatisfied with the result, is allows to submit the appeal together with RM100 per subject within 1 month of notification of the results.

Examination

- The exam fees per subject is RM50.00 and the processing fee is RM50.00
- Examination conducted yearly usually in month of July. The examination venue be decided by Board, and in Johor Bahru areas will be having one examination center.

UVA's Intake & Fee Structures

- Courses Intakes will be every August/September and January/February yearly.
- Each intake (January / February or August / September yearly) will be conducting 3 subjects from each Part 1 & Part 2 modules.
- Every subject will be conducted in evening (weekday) from 7.15pm to 9.45pm weekly. Weekend classes will be arranged based on demand.
- Face to face learning where participants are able to communicate with experience lecturers.
- Course fee included study + revision classes, with class notes and past year questions provided.
- Student is responsible for full course fee payment commitment in event of non-attended classes for whatever reasons. No replacement classes shall be arranged if student(s) missed the respective class
