
ACCA & CAT Qualifications Pathway

Level of CAT is equivalent to the first year of a university degree programme. Consequently, CAT graduates are allowed to move directly to ACCA skill level, where fully exempted from ACCA knowledge level exams.

Examinations

All examination are conduction based on paper-based examination. They are total 4 series examination yearly held in month of March, June, September and December, for ACCA skill modules to essential and professional level.

As for ACCA Knowledge modules and CAT qualifications papers examination will be held in two session yearly, that on Jun and December.

Student is allows to take maximum of 4 papers (within same module) at each session examinations. The maximum time frame given to complete the whole qualification is at 10 years.

All fee payable to ACCA will be in sterling pound (£) currency.

Examination fee are from £72 to £135 per paper depending on subject levels.
